

## Oil & Lubricants Promotion Terms and Conditions

### 1. Promoter

The promoter is McIntosh CE Pty Ltd (or insert correct legal entity) of 525 Great Eastern Highway, Redcliffe, WA, 6104 ("Promoter").

### 2. Promotion period

The promotion runs from 1 April 2026 to 31 August 2026 ("Promotion Period").

Entries must relate to eligible purchases made during this Promotion Period.

### 3. Eligibility

- Entry is open to Australian residents aged 18 years or over.
- The promotion is open to retail customers only.
- Employees of the Promoter, its related companies, dealerships, agencies, and their immediate families are not eligible to enter.
- For a dealer to offer this retail promotion, they must order, or have in the past 12 months, ordered the eligible oils from MCE and not CNH directly.

### 4. How to enter

To enter, an eligible entrant must, during the Promotion Period:

1. Purchase genuine CASE Construction Equipment (CNH) oil from a participating CASE Construction Equipment dealership; and
  2. At the time of purchase, complete the digital entry form via the QR code provided; and
  3. Provide either:
    - a valid invoice number, or
    - a clear photo of the cash sale receipt.
- Late, incomplete, or illegible entries may be deemed invalid.

### 5. Entries

One (1) drum/container of eligible oil or lubricant equals one (1) entry.

Multiple drums purchased in a single transaction may be entered on one entry form, provided the quantity entered matches the invoice or receipt.

Each separate purchase requires a separate entry form.

Entries only apply to the draw for the month following the purchase and do not roll over into future draws unless a new eligible purchase is made.

### 6. Draw details

One (1) prize will be drawn each month during the Promotion Period, for a total of five (5) prizes.

Draws will take place on the 1st of each month, beginning 1 May 2026, for purchases made in the previous calendar month.

Draws will be conducted by the Promoter at 525 Great Eastern Highway, Redcliffe, WA, 6104.

The prize will be delivered to the dealership, and the dealership is responsible for passing the prize on to the winning customer.

Prize fulfilment will be coordinated by the Promoter.

If an entry does not match the corresponding invoice or receipt, the entry will be deemed invalid and a new winner will be drawn.

The Promoter may disqualify any entrant who tampers with the entry process or submits misleading information.

## 10. Unclaimed prizes

If a prize is not claimed within 28 days of winner notification, the Promoter reserves the right to redraw the prize in accordance with applicable laws.

Nothing in these Terms & Conditions limits any rights a consumer may have under the Australian Consumer Law.

Except for any liability that cannot be excluded by law, the Promoter is not responsible for any loss, damage, or injury suffered as a result of entering the promotion or accepting the prize.

Personal information collected as part of this promotion will be used solely for the purpose of administering the promotion, contacting winners, and prize fulfilment.

Personal information will be handled in accordance with the Promoter's privacy policy.

## 13. General
